- 1. Hal called meeting to order at 10:05.
- 2. Introductions were made.

3. Revisit Agenda:

a. Nothing changed or added at this time. However, committee members were given time to review minutes from March 4th meeting since sent late.

4. Old Business:

- a. March 4th 2019 Minutes: Joe made motion to approve. Michael seconded. Committee voted to approve minutes.
- b. March 5th emergency Employment First Advisory Partnership (EFAP) meeting on the CDLE Employment First appropriation.
 - CCDC and their legislative collaborative, One Strong Voice, sent a signed letter of concern that an Office of Employment First (OEF) based within the UCEDD might only focus on people with I/DD and not be cross-disability.
 - Bob suggested an emergency meeting of EFAP be convened to deal with the concern..
 - The JBC figure setting document for CDLE (of February 21st) stated the vision and mission of the OEF was specifically cross-disability.
 - The result was that collaboration occurred to not put the appropriation at risk.
- c. March 13th JBC HCPF figure setting on the HCBS-DD waitlist and Employment First appropriation
 - DD Waitlist: HCBS DD Waitlist- 300 resources were funded by the JBC. Now working to see if can get additional resources this year to further reduce the waitlist.
 - The proposal of a collaboration of DD-related agencies/associations is to request funding for 300 resources, give the providers in the DD community the same rate of pay increase that was going to the state employees and fund a wait list study.
 - Positioned for possibly more than 300 coming off the waitlist following the next state revenue forecast.
 - Over 60% of the way though the 120 session. Fewer bills have been introduced so far and worrisome.
 - Hal would like the committee to focus on systemic denial of Medicaid eligibility, which affects the majority of our population, next year. As late summer, around August, this committee should review.
- 5. <u>New Business:</u> In the fall Hal suggested the committee determine the bills of importance and start researching to take action.
 - a. HB 19-1194 Discipline of preschool through 2nd grade students
 - Did pass through the education committee last week and is before the full house today for a second read.
 - This is a bill with four sponsors.
 - b. HB 19-1007 Employment support pilot:
 - Bill that provides funding to employment support agencies to people with low income, not disability focused but does impact them. Includes things like counseling on resumes, applications, dress for success sessions.
 - c. HB 19-1223 SSI & SSDI application support
 - Bill set forth to help people applying for SSI or SSDI. Typically you have to apply three times to be successful and that is not a guarantee. Will be heard March 19th.
 - d. HB19-1104 Rights of those represented by the Office of the Respondent Parent's Council
 - Was signed on March 7th by the governor.

- e. HB 19-1028 Medical marijuana for autism
 - Autism Society board discussed this but were not in favor because the wording was problematic, which could be corrected with an amendment. Bill has been passed by the House and was scheduled last Thursday to the senate.
- f. SB 19-172 Creating the crime of unlawful abandonment and unlawful confinement
 - This bill is likely to pick up opposition because of the concern for unintended for side consequence. Julie Reiskin sent some concerns to the bills sponsors that states, not considered abonnement when an at risk adult is left alone when their caregiver has to go to work and paid caregiver services are not available. Bill status: has been assigned to Health and Human Services.
- g. HB 19-1017 Pilot K-5 social workers
 - Has a fiscal note of \$16 million for five schools only.
 - h. HB 19-1225 Cash bill for petty and cash bills ends abuse under offense under a misdemeanor. This not covered in the Council's present Five Year Plan but Jessica wanted to bring forward maybe to include in the next Five Year Plan.
- 6. Benu is interested in the DD Waitlist study and Employment First Initiative. Would like to collaborate with CDDC to see how she can be more involved. Bob will email Benu about Employment First.
- 7. Public Comments:
 - a. Gerrie Frohne: anytime you do a study of individuals with disabilities and their families you should consider conflict of interest of those conducting the study. PADCO has done a lot of work with families, and there is often a lack of trust with the people conducting the survey. If a study is done it should be done by a bipartisan organization.
- 8. Jessica made motion to adjourn and Kristen seconded at 12:00.
